Minimum Investment: \$10,000 initial; \$50 each additional investment (may be waived).

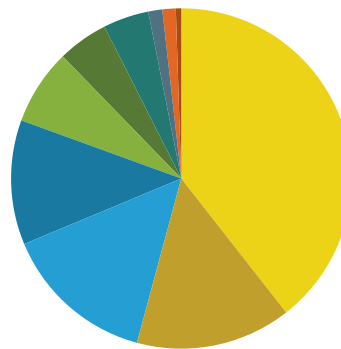
What does the Fund invest in?

The Fund aims to provide a return that is similar to the return of a global neutral balanced mutual fund. It currently does this by obtaining exposure to IA Clarington Global Tactical Income Fund through the use of derivatives. Are there any guarantees?

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

A word about tax

Usually, you will pay income tax on your share of the Fund's income and capital gains if you hold your investment in a non-registered account. Clarington Sector Fund Inc., a mutual fund corporation of which the Fund is a separate class, may pay to shareholders ordinary dividends annually in December and capital gains dividends annually in February, if necessary to reduce its liability for tax. We will send you a tax slip regarding these dividends.

Also, you will usually pay income tax on any increase in the value of your investment when you redeem your investment. You must calculate the amount of your gains.

Who is this Fund for?

Investors who:

- Seek a flow of income and the possibility for capital appreciation*;
- Have low to medium risk tolerance;
- Plan to invest over the medium to long term.

Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk, or consult your advisor.

IA Clarington Global Tactical Income Fund may be more appropriate for registered investment accounts. Ask your advisor about which option may be suitable for you.

*Distributions on this series may include a return of capital, which can erode the value of your investment.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F8 shares of the Fund. The Fund has other series. The fees and expenses are different for each series. Ask your advisor about other series that may be suitable for you.

Sales charges

This series is sold with no sales charge and no redemption fee. However, your dealer may charge you a fee in respect of your investment; any such fee would be set out in an agreement between you and your dealer.

Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As at December 31, 2010, the series' expenses were 1.26% of the net asset value. This equals \$12.60 a year for every \$1,000 invested.

<p>Management Expense Ratio (MER) This is the total of the management fees and operating expenses for Series F8 shares of the Fund, including taxes. We absorbed some of the series' expenses. If we had not done so, the MER would have been higher.</p>	1.17%
<p>Trading Expense Ratio (TER) These are the Fund's portfolio trading costs.</p>	0.09%
<p>Fund expenses This is the total of the MER and TER and is not a separate expense charged to the Fund.</p>	1.26%

Other Fees

You may have to pay other fees when you sell or switch shares of the Fund.

Fees	What you pay
Short-term trading fee	2.00% of the value of the shares you sell or switch within 30 days of buying them. You may be charged 2.00% of the value of the shares you sell or switch between 31 and 90 days of purchase. This fee goes to the Fund.
Switch fee	Your advisor's dealer may charge you up to 2.00% of the value of the switched shares.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy securities of a mutual fund within two business days after you receive a copy of the simplified prospectus; or
- cancel your purchase within 48 hours of receiving confirmation of your purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
